We/I request that the following item be placed on the agenda for the next meeting of the NCHSAA Board of Directors:

Recommendation/Proposal: (State in detail the recommendation/proposal)

We would like for the Board to approve the adoption of the 35 second shot clock rule in basketball that has previously been approved by the NFHS. We would propose that the adoption be phased in over a 3 year period in order to give all schools ample time to get the clock & equipment purchased & installed. Perhaps in the first year the shot clock could only be used in non-conference games- and only if mutually agreed upon by both teams in advance. In year 2 entire Conferences could be given the option of adopting the shot clock for use in all conference games (but not in Conference Tournament nor State Playoffs). Then in year 3 it would be required in all Varsity games and used in the state playoffs as well. We would recommend the caveat be added to the Shot Clock rule that anytime the mercy rule goes into effect and the game clock is no longer stopped on dead balls, that the shot clock be turned off as well.

• Rationale: (Why should the board consider and possibly pass this recommendation?) Middle school & High School basketball in the United States are literally the only places in the world that play basketball without a shot clock. Since the NFHS adoption, more and more states are adopting the use of the shot clock, including our neighboring states in the Southeast Section. The shot clock guarantees more possessions for both teams. Therefore, a team that is trailing by 6-15 points in the 4th quarter of a game is not forced to foul early in order to get the ball back – they can play good defense with the knowledge the opposing team must take a shot within 35 seconds. With less intentional fouling, thus fewer free throws being shot, the length of time it takes to play games could actually be shortened.

• Budget Impact: (What does this mean to a school's/athletic department's finances?) Depending on the clock system a school chooses, it can cost between \$3000 - \$4000 to purchase and install the clocks. There are timing companies that will offer discounted packages to entire Districts that purchase multiple units from them for all of their high schools. When Georgia voted to phase in the Shot Clock, Daktronics offered a price of \$3500 per school if the state would call them the "official shot clock timing partner" for the state (though every school was not required to purchase from Daktronics).

• Educational Impact: (Does this mean loss of school time? Does it interfere with study time?) No – in fact if it indeed does reduce the length of time required to play games, students may get home earlier from games

• Gender Impact: (Is this proposal fair to males and females?) This rule would be applied the same to both Boys & Girls basketball.

• Effective Date: (When would this go into effect?) We have proposed a phase in plan above. We would hope the Board could start the initial voluntary use during the 2024-25 season and have it fully implemented and used in all games all season by 2026-27.





NCHSAA Officiating Program: Phase 2

These efforts advance the recommendations made in the NCSHAA Ad Hoc Subcommittee's Executive Summary from October, 2022.

Representation and Partnership

To further address the issues of recruitment and retention of NCHSAA officials, the next phase is the integration of our program into the organization. Central to that effort is the establishment of the Officials' Advisory Council, a diverse group representative of all officials in the state. The mission of the OAC is to interact with the state's officials, identifying issues and developing solutions to propose and work on with the NCHSAA. This group advocate for all officials year-round.



Attached (and at this link) is a suggested application for officials to indicate they wish to serve. We recommend the OAC be established and working by September 1. Each official chosen serves for two years, with a commitment to work on issues like the following:

- * Administering a yearly survey to all officials to explore their satisfaction to track growth and deliver the curated results yearly to the Board Subcommittee on Officiating. This outreach will make officials feel a part of the organization and give them a voice.
- In conjunction with the NCHSAA Supervisor of Officials, study and propose an evolution of the training process of each sport.
- Interacting with the NCHSAA staff to develop innovative and actionable solutions to stem the challenges of recruitment and retention.
- Cultivating appropriate and relevant commercial messages to the state's officials, offering value-added incentives for NCHSAA corporate sponsors.

For the OAC to be effective for both officials and the NCHSAA, it must be empowered to act as a representative body that can affect positive change in the community. Objectives and goals require resources. We propose the OAC be funded at \$60,000 yearly to make investments in the officiating community like these:

- * Officials looking to advance their craft attending an off-season training program can apply for a grant. They would be required to make an additional two-year commitment to being an NCHSAA official if approved.
- Regional Supervisors who recruit new officials who cannot afford the start-up costs can apply for a grant to defray that expense. Those new officials would be required to make a minimum two-year commitment to the NCHSAA if approved.
- Marketing to the state's officials so they are aware of the OAC and understand its purpose. One goal is the NCHSAA having a positive perception by officials because of the partnership.

- * A social media specialist, dedicated to us, who crafts officiating-positive messages for the digital assets for recruitment and increased pride.
- ***** A yearly stipend for each member of the Committee to incentivize their participation.

With funding, the OAC initiative can do things where officials know they have representation and there is benefit where the items funded give credit to the NCHSAA. We wish for this group to be a work horse so officials know we're empowered to advance agenda items. With its establishment and formal funding, the NCHSAA wins perceptually, stemming attrition.

Other items on the Officials' Advisory Council:

- * The initial choices should serve at staggered lengths so when the OAC seeks new members, there is not an overhaul of the entire Council.
- * An active or retired official for the OAC will be chosen to chair the group strategically through its work. The chairperson serves for a period of three years to lend the group a level of consistent leadership.
- * This work will be done in partnership with the Supervisor of Officials Cecil Mock and official representative to the Board, Elbert Lassiter.

The Fee Increase and Another Financial Perk

The fee increase approved by the Board was very positively received. To slow attrition of tenured officials, we propose the approval of a registration fee discount for long-term officials and a registration fee discount for multi-sport officials. Because we do not know the impact this will have on the operating budget of the NCHSAA, we cannot suggest an appropriate discount. We propose this takes effect with fall, 2023 sports programs. Furthering a financial reward to tenured officials will go a long way to retaining them.

Sportsmanship

In our summer survey, 94% of officials indicated they'd participate offering feedback on sportsmanship and facilities at schools after their contests. Giving officials this outlet, and the NCHSAA sharing that information with the school administrators, is powerful to improving game-to-game experiences for the typical official.

We've looked at three different tools to do this. We do not think any of these is ready to be deployed just yet. We would like the Board's permission to continue exploring and developing this item, even testing it, then making our recommendation for your review in the December, 2023 meetings.

Conclusion

These items capitalize on and advance the work done by the Ad Hoc Subcommittee, your Subcommittee on Officiating, and the full Board in the fall. We will make ourselves available to meet, at your convenience, during or before the full Board meetings in May, to participate in conversation about anything here to help move things forward.
