The procedure for verification is the decision of the conference. This procedure should eliminate any possible problems regarding stacking before the playoffs begin. A conference administrator must sign the dual team line-ups before they are submitted to the NCHSAA office.

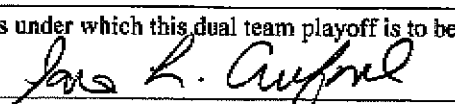
