

# Interscholastic Athletics Independent Appeals Board

## Notice of Appeal

Pursuant to N.C.G.S. § 115C-407.55(4), 16 NCAC 06E .0204(m), and the Memorandum of Understanding between the North Carolina State Board of Education ("State Board") and the North Carolina High School Athletics Association ("NCHSAA"), any public school unit ("PSU") aggrieved by a final decision of the NCHSAA regarding student-athlete eligibility or an alleged violation of the rules adopted by the State Board or the rules and regulations of the NCHSAA may appeal the decision to the Interscholastic Athletics Independent Appeals Board ("Appeals Board").\* The Appeals Board consists of professional educators with experience administering high school athletic programs.

Appeals must be filed within five (5) days of receipt of the final decision of the NCHSAA. If an appeal is time sensitive due to the impact of the decision on an impending athletic event, the PSU should file the appeal as soon as possible and note the date of the athletic event in the appeal. The NCHSAA will have up to five (5) days to respond to the PSU's appeal.

Within thirty (30) days of receipt of the appeal, a panel of three or more members of the Appeals Board will review the appeal and any response filed by the NCHSAA, though the panel may act more quickly for time-sensitive appeals. The panel will affirm the decision of the NCHSAA unless the decision is (1) not supported by substantial evidence or (2) contrary to applicable, law, policy, State Board rule, or NCHSAA rule or regulation. The decision of the Appeals Board is final and not subject to further appeal.

To file an appeal, the designated PSU representative must complete the attached form in its entirety and submit it along with any attachments via email to the parties listed below.
